Offence : Punishable u/s 55 (i) of Kerala Abkari Act

Sentence or Order: The case is committed to Hon'ble Sessions  
Court, Kollam, as provided U/S.232(a) of  
BNSS, 2023.

This case coming on this day, the court passed the following:-

COMMITTAL ORDER

This case, charge-sheeted by the Excise Inspector,  
Karunagappally Excise Range filed Final Report against accused  
in crime No.119/2024 accused alleging offences punishable U/s  
55 (i) of Kerala Abkari Act.

2. Prosecution allegation in brief is that on 14.08.2024 at  
06.20pm, Excise officials found the accused engaged in illegal  
sale of liquor by possessing 900ml of Indian Made Foreign

Liquor (IMFL) seized from the house of the accused. Thus the accused committed alleging the above mentioned offences in contravention of provisions of Abkari Act.

3. Accused appeared on summons. She was served with copies of relevant prosecution records. After perusing the prosecution records and hearing of both sides it appears that the offence alleged against the accused is exclusively triable by Court of Session, as provided U/S.232(a) of BNSS, 2023.
4. Hence this case is committed to the Hon'ble Sessions Court, Kollam, after complying with S.230 BNSS, 2023.
5. Send the entire case records to the Hon'ble Sessions Court, Kollam, as provided U/S. 232(c) of BNSS, 2023
6. The committal of the case is being notified to the Public Prosecutor, Kollam, as provided U/S. 232(d) of BNSS, 2023
7. Material objects, if any shall be sent forthwith.
8. Accused is directed to appear before the Hon'ble Court of Session, Kollam as and when demanded by that Hon'ble Court.
9. Office is directed to send case records forthwith.
