Sentence/Order	:	The case against accused is committed to the Hon'ble Sessions Court, Kollam U/s.232(a) of BNSS, 2023.

This case having been finally heard on today, this court delivered the following :

**ORDER**

This is a case charge sheeted by the Sub Inspector of Police, Sakthikulangara Police Station against the accused alleging offences punishable u/ss.127(2), 115(2), 118(I), 118(2), 110 BNS.

2. The prosecution's case is that, the defacto complainant refused to accompany the accused for consuming alcohol, which enraged the accused. On 20.11.2025 at about 9:15 p.m., when the defacto complainant reached in front of his house at Mukaddas, the accused attempted to attack him with an iron rod using his left hand. In the said incident, the defacto complainant sustained an injury on his left palm. The accused also kicked the defacto complainant on his right hip. Subsequently, on 24.12.2025 at about 5:30 p.m., the accused wrongfully restrained CW1 and assaulted him by beating him on his face and back and by throwing stones at him, thereby causing a fracture. Thus the accused is committed offences punishable under sections. 127(2), 115(2), 118(I), 118(2), 110 BNS

3. On filing final report, the case was taken on file as CP 13/26 and summons were issued to the accused pursuant to which he appeared before the court. Accused had been already enlarged on bail during the crime stage. Copies of all

relevant prosecution records were given to the accused and thereby mandate u/s. 230 of BNSS 2023 was complied with.

4. Heard. Perused records.

5. Since the offences alleged against the accused is exclusively triable by the Hon'ble Court of Sessions, this case is committed to the Hon'ble Court of Sessions, Kollam as provided U/s.232(a) of BNSS 2023.

6. Submit the records of the case, documents, articles if any U/s.232(c) of BNSS 2023 and property if any shall be send subject to Rule 77(2) of Criminal Rules of Practice, Kerala.

7. Notify the Public Prosecutor of the commitment of the case to the Court of Sessions U/s.232(d) of BNSS 2023.

8. Accused is directed to appear before the Hon'ble Court of Sessions, Kollam as and when demanded by that Hon'ble Court.

9. Office is directed to send case records forthwith.
