Petition : U/s.23(2) of the Protection of Women from
Domestic Violence Act, 2005.

This petition having been heard on today and court passed the following orders on the same day:

ORDER

1. This is an application filed U/s.23(2) of the Protection of Women from Domestic Violence Act, 2005 seeking interim orders.
2. Heard the learned counsel for the petitioners. Perused the affidavit and other documents filed along with the petition.
3. I am satisfied that the application *prima facie* discloses that there is a likelihood that the respondents may commit acts of domestic violence. Hence, interference of this court is highly necessary for the protection of the petitioners/aggrieved persons

from domestic violence. Hence, invoking power U/s.23(2) of Protection of Women from Domestic Violence Act 2005, the following interim order is passed:-

- (1) The respondents are hereby restrained from harming or injuring or endangering the health, safety, life or limb of the aggrieved persons or from causing any act of physical or verbal or emotional violence against the [petitioners](#).
- (2) The respondents are hereby restrained from committing any act of domestic violence against the petitioners at Kazhakootath Padinjattathil, Kuripuzha cherry, Kavanad PO, Kollam.
- (3) The respondents are hereby restrained from taking minor children out of the custody of the aggrieved person forcefully and without an order from a Court of Law.
- (4) Hence, the petition is allowed in part. Other relief will be considered after hearing both parties.
- (5) Issue a copy of this order of free of cost of the parties to the application, respondent and officer in charge of Police Station concerned.
