Sentence/Order	:	The case against the accused is committed to the Hon'ble Sessions Court, Chathannur U/s.232(a) of BNSS.

This case having been finally heard on today, this court delivered the following :

**ORDER**

This is a case charge sheeted by the Excise Range Officer, Chathannur Excise against the accused alleging offence punishable U/s.55(i) of Kerala Abkari ct.

2. The prosecution case is as follows : On 01.01.25 at 9.30 am, near No.MYD MT31/14/6 electric post near Mayyanadu LMS LP School, the accused was found in possession of 04. liters Indian made Foreign liquor and was conducting illegal sale. Thus the accused committed the offence punishable under section 55(i) of Kerala Abkari Act.

3. On filing final report, the case was taken on file as CP 27+/26 and summons was issued to the accused pursuant to which he appeared before the court. Accused had been already enlarged on bail during the crime stage. Copies of all relevant prosecution records were given to the accused and thereby mandate u/s. 230 of BNSS was complied with.

4. Heard. Perused records.

5. Since the offences alleged against the accused is exclusively triable by the Hon'ble Court of Sessions, this case is committed to the Hon'ble Court of Sessions, Chathannur as provided U/s.232(a) BNSS.

6. Submit the records of the case, documents, articles if any U/s.232(c) of BNSS, 2023 and property if any shall be send subject to Rule 77(2) of Criminal Rules of Practice, Kerala.

7. Notify the Public Prosecutor of the commitment of the case to the Court of Sessions U/s.232(d) of BNSS.

8. Accused is directed to appear before the Hon'ble Court of Sessions, Chathannur as and when demanded by that Hon'ble Court.

9. Office is directed to send case records forthwith.
