This case coming on this day, the Court passed the following:-

ORDER

The case arose from final report filed by the Inspector of Police,
Chathannur Police Station in Crime No. 1905/2025 alleging that the accused
committed offences punishable u/ss. 85, 110 of BNS and sec. 66 E of The
Information Technology (Amendment) Act, 2008.

2. The prosecution case in brief is as follows:- CW1 is the wife of the accused. The accused committed cruelty against CW1 demanding more properties. The accused took photographs and videos of acts of sexual intercourse between the accused and CW1 and circulated the same among the friends and relatives. On 28.10.2025 at 6.30 pm the accused attacked CW1 at the bedroom of the house of them and attempted to commit murder by squeezing the neck of CW1. Thereby the accused has committed the offences punishable u/ss. 85, 110 of BNS and sec. 66 E of The Information Technology (Amendment) Act, 2008.

3. The accused was arrested and remanded to judicial custody on 30.10.2025. The accused was enlarged on bail as per the order of Hon'ble Additional Sessions Court - I, Kollam vide Crl. MC. No. 2887/2025 dated 11.11.2025. Copies of all relevant prosecution records were given to the accused and thereby mandate u/s. 230 of BNSS was complied with.

4. Heard the learned counsel for the accused and the learned Assistant Public Prosecutor. Perused records.

5. Since the offences alleged against the accused are exclusively triable by the Hon'ble Court of Sessions, this case is committed to the Hon'ble Court of Sessions, Kollam as provided u/s. 232(a) BNSS.

6. Submit the records of the case, documents, articles if any u/s.232(c) of Bharatiya Nagarik Suraksha Sanhita, 2023 and property if any shall be sent subject to Rule 77(2) of Criminal Rules of Practice, Kerala.

7. Notify the Public Prosecutor of the commitment of the case to the Court of Sessions u/s. 232(d) of Bharatiya Nagarik Suraksha Sanhita, 2023.

8. The office is directed to keep certified copies of all relevant records before sending to the Hon'ble Court of Sessions.
