This case coming on this day, the Court passed the following:-

ORDER

The case arose from final report filed by the Sub Inspector of Police,
Paravur Police Station in Crime No. 1731/2025 alleging that the accused

committed offences punishable u/ss. 296(b), 126(2), 115(2), 118(1), 140(4), 110 r/w 3(5) BNS.

2. The prosecution case in brief is as follows:- At 08.30 p.m. on 31.10.2025 the accused who were provoked that CW1 had questioned accused no. 2 who had taken his bike, accused no. 1 and 2 abducted CW1 in a bike and took him to the place of occurrence. Accused no. 1 using a broken piece of spocket struck at his forehead while accused no. 2 held him tight. Accused no. 1 further attacked the victim at his head and back. Accused no. 2 continued the attack with the spocket. As he fell down accused no. 1 and 2 further assaulted him. The attack aimed at his head using spocket was capable to have resulted in fatal injury if it was not blocked by the victim. The accused have hence committed the offences punishable u/ss. 296(b), 126(2), 115(2), 118(1), 140(4), 110 r/w 3(5) of BNS.

3. Accused no. 1 was arrested and remanded to judicial custody on 05.11.2025 and he was enlarged on bail as per the order of Hon'ble Principal Sessions Court, Kollam vide CrI. MC. No. 3090/2025 dated 22.11.2025. Accused no. 2 was arrested and remanded to judicial custody on 07.11.2025 and he was enlarged on bail as per the order of this court vide CMP No. 2890/2025 dated 17.12.2025. Copies of all relevant prosecution records were given to the accused and thereby mandate u/s. 230 of BNSS was complied with.

4. Heard the learned counsel for the accused and the learned Assistant Public Prosecutor. Perused records.

5. Since the offences alleged against the accused are exclusively triable by the Hon'ble Court of Sessions, this case is committed to the Hon'ble Court of Sessions, Kollam as provided u/s. 232(a) BNSS.

6. Submit the records of the case, documents, articles if any u/s.232(c) of Bharatiya Nagarik Suraksha Sanhita, 2023 and property if any shall be sent subject to Rule 77(2) of Criminal Rules of Practice, Kerala.

7. Notify the Public Prosecutor of the commitment of the case to the Court of Sessions u/s. 232(d) of Bharatiya Nagarik Suraksha Sanhita, 2023.

8. The office is directed to keep certified copies of all relevant records before sending to the Hon'ble Court of Sessions.
