This case coming on this day the court passed the following:-

COMMITTAL ORDER

This case, charge-sheeted by the Sub-Inspector of Police,
Oachira P.S in Crime No.401/2025 involves the accused allegedly

committing offences punishable u/s 64, 64(2)(m), 78(1)(ii), 332(c), 351(2), 296(b), 324(4), 238 of The Bharathiya Nyaya Sanhitha, 2023 and Sec. 67(A) of Information Technology Act 2000.

2. The prosecution's case is that during the period from 10.11.2024 till 18.11.2024, the accused sexually abused the informant and committed sexual intercourse with her at the house of the accused. During that time, the accused took the nude photographs of the informant and threatened her. It is further alleged that on 27.02.2025, the accused trespassed into the house of the informant and criminally intimidated her. Accordingly, the accused is alleged to have committed the aforementioned offences.
3. The court took cognisance of the above said offences against the accused and summons were ordered.
4. The accused appeared in pursuance of the summons and the copies of relevant records were furnished to him as mandated under Section 230 of The Bharathiya Nagarika Suraksha Sanhitha 2023.
5. Since the final report disclosed the commission of offences punishable under sections 64, 64(2)(m), 78(1)(ii), 332(c), 351(2),

296(b), 324(4), 238 of The Bharathiya Nyaya Sanhitha, 2023 and Sec. 67(A) of Information Technology Act 2000 of which some are exclusively triable by the Hon'ble Court of Session, committal proceedings were initiated against accused.

6. The accused is already on bail, and bond for his appearance has also been executed.
7. Hence, the case is committed to the Hon'ble Sessions Court, Kollam U/s. 232 (a) of BNSS 2023.
8. Office of this court is directed to send the entire case records including the material objects if any, to the Hon'ble Court of Session, Kollam and notify the same to the Public Prosecutor concerned.
9. Accused is directed to appear before the said court as and when summoned.
