The sentence and the provision of law under which it was imposed by the lower Court. : The accused is sentenced to undergo simple imprisonment for one month and to pay fine of Rs.2,26,100/- under section 138 of the Negotiable instruments Act and in default of payment of fine the accused shall undergo simple imprisonment for three months. If the fine is paid or realized, the entire amount shall be paid to the complainant as compensation under section 395 of BNSS
