**ORDER**

This petition is filed under Order XXXIX, Rule 1 and 2 of CPC.

Heard. Perused affidavit and records. I am satisfied that the petitioner is having prima facie case and delay in service of notice will defeat very purpose of this case. Hence, I am of the view that interim injunction before notice can be ordered. Hence, the respondents are restrained by an order of interim injunction from creating any obstruction, or block in the plaint "C" schedule property and also from obstructing the petitioners and devotees from using the petition "C" schedule property as a motorable access to petition "A" schedule property till 26.02.2026.
