**O R D E R**

1. This is a case charge sheeted for offence punishable u/S.  
326(g),324(1) of BNS & Section 75 of Juvenile Justice Act.

2. The allegations against the accused is that, on 06.10.2025 evening  
at Kundamthadam in Vayakkara amsom, the accused, son of CW1, came to the  
house in a drunken condition, who is the guardian of CW3 and beat her face  
and caused injury to her. Further the accused set fire inside the house some  
time between 18.00 hours on 06.10.2025 and 10.30 hours on 07.10.2025 and  
destroyed the study materials and dresses of the children and caused damages

to the tune of Rs.5000/-. Thereby the accused is said to have been committed the offence punishable u/s 326(g),324(1) of BNS & Section 75 of JJ Act.

3. On appearance of the accused herein, copies of relevant case records were furnished to him u/s 230 of BNSS. Accused is released on bail. He is defended by a counsel appointed by him. As per Section 86(4) of Amendment Act 2021, all offences under the Juvenile Justice (Care and Protection of Children) Act shall be triable by the Hon'ble Children's Court. Hence the case is to be committed to the Hon'ble Session's Court.

4. Upon going through the records, it is seen that the offence alleged against the accused u/s Sec.75 of JJ Act is exclusively triable by Hon'ble Children's Court. Hence, the case against accused is committed to the Hon'ble Session's Court, Thalassery U/s 232 of BNSS.

5. The properties, if any, produced in this case shall be forwarded to the Hon'ble Children's Court as per rules.

6. Notify the public prosecutor of the commitment of this case.
