2. Both sides represented. Mediation Agreement filed. Heard. The matter is settled, but the counsel for defendant argued that the Suit is to be dismissed after recording the terms of mediation. On perusal of Mediation Agreement I am satisfied that there are certain terms which are executable in case of default. In such a situation dismissing the suit will cause prejudice to parties. Further the mediation agreement itself prays to decree the Suit. Hence Suit is decreed as per the terms of Mediation Agreement. Mediation Agreement shall form the part of the decree.
