This suit coming on the 12th day of March, 2026 for final hearing before me in the presence of S/Sri.Padmaja Padmanabhan and Korembeth Rajeevan, Advocates for the Plaintiff ; Defendant No. 2 remained absent declared ex-parte ; Defendant No.1 reported died and having stood over for consideration till this day; the court delivered the following:

FINAL JUDGMENT

The suit is for a partition.

2. A preliminary decree was passed, dividing the property into 3 equal shares and allotting 1 share to the plaintiff and 2 share to the defendant No. 2 on payment of requisite Court fee. Thereafter a petition was filed for the appointment of the Commissioner. As defendants were already ex parte, Advocate Sri Pramod E. Vijay was deputed to inspect the property and file a report to effect partition. Commissioner inspected

the property and filed report, plan, share list and Valuation statement. No objection was raised against the Commissioner's report and plan. Hence Commissioner's report, plan, share list and Valuation statement are marked as Exhibits C1 to C4 and a final decree is passed as follows:

1. Plot 'B' in Exhibit C2 plan is allotted to the share of the plaintiff.
2. Plaintiff can deposit in the Court the amount required to purchase Non-Judicial Stamp Paper for engrossing the final decree, within two months.
3. Exhibits C1 to C4 shall form part of the final decree.
