**ORDER**

This is a case charge sheeted by the Excise Inspector, Excise Range Office, Mattannur against the accused in OR.No.176/2025 for the commission of an offences punishable under Section 55(i) of Kerala Abkari Act.

2. Prosecution case in brief is as follow: On 22<sup>nd</sup> November 2025 at 7.30pm near the building bearing No.XXXII/159 of Iritty Municipality at Chavassery Amsom Desom, the accused was found illegally selling Indian Made

Foreign Liquor and hence the accused is said to have committed the offence punishable under Section 55(i) of Kerala Abkari Act.

3. The accused was enlarged on bail. He entered appearance before this court responding to summons. All relevant copies of prosecution records were furnished to the accused and thereby the requirements under Section 230 of BNSS was duly complied with. The offence under Section 55(i) of Kerala Abkari Act is triable exclusively by the Court of Session. Therefore the case against the accused is committed to the Hon'ble Court of Session Thalassery under Section 232 of BNSS.

4. Transmit the case records to the Hon'ble Court of Session, Thalassery and the property produced if any, shall be sent subject to rule 77(2) of the Criminal Rules of Practice, Kerala.

5. The accused shall appear before the Hon'ble Court of Sessions, Thalassery as and when the court so directs.

6. Notify the commitment of the case to the Public Prosecutor.
