ORDER

This is an application under Section 23 of The Protection of Women from Domestic Violence Act, 2005 (*hereinafter referred to as '2005 Act' for short*) seeking interim reliefs against the respondent.

2. Petitioner present. Heard learned the counsel appearing on behalf of the petitioner. Perused the application and the accompanying affidavit therein. The above application prima facie discloses commission of an act of domestic violence by the respondent against the petitioner. Considering the facts and circumstances and upon consideration of the arguments advanced by the

learned counsel for the petitioner, this court is satisfied that there is every likelihood that the respondent may further commit physical abuse to the petitioner and her child. Hence, this court is of the view that it is highly necessary to pass an interim protection order U/s 18 of the 2005 Act for preventing any further act of commission of domestic violence. The other reliefs sought in the above interim application can be considered after hearing the respondent.

In the result, the above application is partly allowed.

- A. The respondent hereinabove is hereby restrained by way of an interim protection order **U/s 18 of The Protection of Women from Domestic Violence Act, 2005** from committing any act or omission or commission or conduct that harms or injures or endangers the health, safety, life, limb or wellbeing; whether mental or physical against the petitioner hereinabove and her minor child, including any physical abuse, sexual abuse, verbal and emotional abuse or economic abuse.
- B. Issue a copy of this order free of cost to the petitioner.
- C. Attach a copy of this order along with the notice to the respondent.
- D. The Secretary, Gram Nyayalaya, Iritty at Payam shall communicate the order to SHO Chakkarakkal Police Station and SHO Peravoor Police Station today itself.
- E. The Secretary, Gram Nyayalaya, Iritty at Payam shall communicate the order to the Protection Officer, Kannur District today itself.
- F. Issue notice to respondent. Await return of notice.
