Heard, perused the records and passed the following:

### J U D G M E N T

1. Accused stands trial for the offence punishable U/S. 126(2) & 115(2) of BNS. The prosecution case in brief is that on 26.12.2024 at 08.00 p.m. in unnumbered . house situated in ward no. 4 of Padiyoor Grama Panchayath in Alathuparamba-Tayikundam road. In the bedroom of the house due to the animosity arising due to the fact that charge witness no. 1 asked for the money which was lent to accused. Accused wrongfully restrained CW 1 and kicked on back side and on face of CW 1 and pushed CW 1 to the floor and kicked CW 1 thereby committing offences under 126 (2) and 115 (2) of BNS.
2. For the same, Irikkur Police had registered Crime No. 819/2024 Under Section 126 (2) and 115(2) of BNS. In the same, final report was filed before this court and this court has taken cognizance of the same and the same was

registered as CC 5/2025. In CC5/2025, summons was issued to the accused. Accused did not appear before this court. Subsequently warrant was issued to accused. Accused was arrested and produced and accused was released on self-bond. Copy was given . Subsequently accused did not appear before this court and accused was arrested and produced and accused has been remanded since 25.03.2026. Subsequently accused pleaded guilty. Accused has endorsed on the plea form that he has made the plea voluntarily. I am satisfied that accused has made the plea voluntarily. The offences alleged are under Section 126(2)of BNS and Section 115(2) of BNS.

In the result, Accused is convicted for a period of 3 months for offence punishable under Section 115(2) of BNS and accused is convicted for simple imprisonment of 1 month for offence punishable under Section 126(2) of BNS, IDSI, Accused shall pay a fine of ₹ 10,000/-. Set off is allowed for the period from 25.03.2026 to 23.04.2026, the period already undergone by him as under trial prisoner. All the sentences shall run concurrently.
