- Offences : u/s.296(b), 75(1), 351(2) of BNS
- Order : Case against the accused is committal to the Hon'ble Court of Session, Kottayam, u/s.323 Cr.P.C.

This case having been finally heard on this day, the Court passed the following:

**ORDER**

1. This is a case instituted on a report filed by the Kuravilangadu police station in Cr.615/25 alleging that the accused had committed offences punishable u/s. 296(b), 75(1), 351(2) of BNS.
2. The prosecution case in brief is as follows :- On 30/04/2025 at 04.00 pm, while the defacto complainant's children playing ball, accused hurled abused against them. When the defacto complainant questioned it, accused uttered obscene words towards them and criminally intimidated to burn her family with petrol, if she file the complaint against him. It is further alleged that accused showed his nudity towards the defacto complainant. Thereby accused alleged to have committed the offences punishable u/s. 296(b), 75(1), 351(2) of BNS.
3. The accused was arrested and produced before this Court. Later bail granted to the accused. After appearance of accused copies were given.

4. This case was originally taken on file as CC.794/2025. Later it was found that the offences alleged are exclusively triable by a Court of Sessions, the case has been converted to CP. 10/2026, that is the present case.
5. On going through the records it appears that the offence u/s 75(1) of BNS alleged against accused is exclusively triable by Hon'ble Court of Session. Hence the case is committed u/s. 323(a) CrPC to the Hon'ble Court of Session, Kottayam.
6. The accused shall appear before the Hon'ble Court of Session, Kottayam as and when required.
7. Forward the case records and material objects to the Hon'ble Court of Session, Kottayam forthwith as provided u/s. 323(c) Cr.P.C.
8. Notify the committal of the case to the Public Prosecutor, Kottayam as provided u/s. 323(d) Cr.P.C.
