This case having been finally heard on this day, the Court passed the  
following:

**ORDER**

1. This is a case instituted on a report filed by the Kuravilangadu police station in Cr. No.353/2025 alleging that the accused had committed offences punishable Under sections 296(b),118(1), 118(2),110, 324(4) of BNS.
2. **The prosecution case in brief is as follows:-** Due to the previous enmity towards defacto complainant, on 11/03/2025 at 06.30 pm, at Vellappally Kunnumpuram Bhagam, accused beaten on the head of the defacto complainant using an iron pipe with the knowledge that his act may cause the death of defacto complainant and thereby caused injury to him. Thereafter accused with an intention to commit culpable homicide, again beaten on the face of the defacto complainant using the aforesaid iron pipe and as he blocked the same using his hand, he sustained injuries and fracture on his left little finger. His mobile phone was also broken.

Thereby accused committed the aforesaid offences.

3. The accused was arrested and produced before this Court and later bail granted to the accused.
4. Accused was appeared before this Court and copies of the prosecution records were furnished.
5. On going through the records it appears that the offence alleged u/s 110 of BNS against accused is exclusively triable by Hon'ble Court of Session. Hence the case is committed u/s. 232(a) BNSS to the Hon'ble Court of Session, Kottayam.
6. Accused shall appear before the Hon'ble Court of Session, Kottayam as and when required.
7. Forward the case record and material objects to the Hon'ble Court, forthwith as provided u/s. 232(c) BNSS.
8. Notify the committal of the case to the Public Prosecutor, Kottayam as provided u/s. 232(d) BNSS.
