4.	The petitioner shall not involve in any other crime while on bail						
5.	If any of the above conditions are violated by the petitioner misusing his liberty, the SHO is directed to approach the jurisdictional Court for cancellation of bail and the jurisdictional Court shall have ample power to dispose the application for cancellation of bail in accordance with law.
