ORDER

This is a case charge sheeted by the Sub - Inspector of police, Karukachal Police station against the accused persons alleging the commission of offences punishable under section 75(1)(iii), 79 of Bharatiya Nyaya Sanhitha (hereinafter referred to as BNS), 2023, S. 66 E, 67 of Information Technology Act (hereinafter referred to as IT Act), 2000 & S.119(1)(b) of Kerala Police Act (hereinafter referred to as K P Act).

2. ***Prosecution case in brief is as follows:*** Informant is the wife of the accused. The accused with the intention to outrage the modesty of the informant and thereby degrade and cause annoyance to her on various dates from 01.06.2025 morphed the photographs of the informant using AI App and published and propagated through telegram, a social media platform, to various persons and thereby the accused person is alleged to have committed the offences punishable u/ss. 75(1)(iii), 79 of Bharatiya Nyaya Sanhitha, 2023, S. 66 E, 67 of Information Technology Act, 2000 & S.119(1)(b) of Kerala Police Act.
3. The accused was arrested and produced before this court on 05.07.2025 and was released on bail as per the order of this court in CMP No. 2362/25.
4. On submission of charge sheet by the Sub-Inspector of Police, Manimala police station, the case was taken on file as CP 21/2025 on the file of this court. Copies of all relevant prosecution records were given to accused persons 1 to 3 and 5 and thereby mandate u/s.230 of Bharatiya Nagarik Suraksha Sanhita was complied with.
5. Heard. Perused records.
6. Since the offences alleged against the accused persons are exclusively triable by the Hon'ble Court of Sessions, this case is committed to the Hon'ble Court of Sessions, Kottayam as provided U/s. 232 of Bharatiya Nagarik Suraksha Sanhita.
7. Submit the records of the case, documents, articles U/s. 232 of Bharatiya Nagarik Suraksha Sanhita and property shall be sent subject to Rule 77(2) of the Criminal Rules of Practice, Kerala.
8. Notify the Public Prosecutor of the committal of the case to the Hon'ble Court of Sessions U/s. 232 of Bharatiya Nagarik Suraksha Sanhita.
9. The office is directed to keep certified copies of all relevant records before sending to the Hon'ble Court of Sessions.
