- ORDER : The case against the above mentioned accused are

committed to the Court of Sessions, Kottayam under section 232(a) of BNSS. Case against A4, A16, A20 and A26 are split up and refiled as CP 94/2025.

ORDER

The final report in this case was filed by the Sub Inspector of Police, Thrikkodithanam Police Station in Crime No.390/2022 against the accused for offence punishable u/s.143, 147, 148, 149, 332, 328 and 323 of IPC.

2. The prosecution case, in brief, is as follows :- On 17.03.2022 at about 2.00 p.m at Madappally Village, the accused persons who are protesting against K Rail Project, formed themselves in to an unlawful assembly, and in furtherance of their common object to obstruct laying of survey stones for K Rail Project, poured kerosene on the body of defacto complainant and other police officials who are deployed there to maintain law and order. The accused persons have inflicted injuries to the defacto complainant and other witnesses, in order to deter them from discharging their official duty. Thus the accused have committed the offences punishable u/s.143, 147, 148, 149, 332, 328 and 323 of IPC.

3. On filing final report, the case was taken on file as CP 58/2023. Case against A1, A7, A9, A10, A11, A12, A13, A14, A15, A18, A21, A23, A24, A25 and A28 are committed to Hon'ble Court of Sessions, Kottayam on 04.06.2025. Case against A2, A3, A5, A6, A8, A17, A19, A22 and A27 split up and refiled as the present one. As the case is exclusively triable by the Court of Session, it is committed to Hon'ble Court of Sessions, Kottayam as contemplated under

section 232(a) of BNSS.

4. The entire records and material objects, if any, shall be forwarded to the Hon'ble Court of Sessions forthwith.

5. Issue notice to the Public Prosecutor, Kottayam regarding the committal of this case as provided u/s.232(d) of BNSS.
