These final decree petitions having been finally heard on 19.03.2026 and the court on 21.03.2026 delivered the following:-

**COMMON FINAL JUDGMENT**

-

Final decree applications filed under Order XX, Rule XVIII of CPC.

- (2) **Gist of the petition in FDA 31/2020** : Petitioner is the 5<sup>th</sup> defendant in the original suit. The suit was filed for partition and separate possession. A preliminary decree for partition was passed on 6.8.1998. As per preliminary decree, the plaintiffs and

defendants were entitled to  $\frac{1}{2}$  share each in the plaint schedule property in OS 365/96 and  $\frac{1}{3}$ <sup>rd</sup> share each in OS 40/1997. Then the 5<sup>th</sup> defendant filed the present final decree application.

(3) **Gist of the petition in FDA 29/2020** : Petitioner is the plaintiff in the original suit. The suit was filed for partition and separate possession. A preliminary decree for partition was passed on 6.8.1998. As per preliminary decree, the plaintiffs and defendants were entitled to  $\frac{1}{2}$  share each in plaint schedule property in OS 365/1996 and  $\frac{1}{3}$ <sup>rd</sup> share each in OS 40/1997. Then the plaintiff filed the present final decree application.

(4) Along with the final decree application, the petitioner had filed a petition to appoint an Advocate Commissioner and Surveyor. Accordingly, Adv. P.A. Sujatha is appointed as Commissioner and Preetha Kumari is appointed as Surveyor to measure out the plaint schedule property. They visited the property for ascertaining the matters and filed the commission report with survey plan on 18.3.2026. The respondents filed no objection to the commission report.

(5) The said commission report with survey plan is marked as Ext.C1 series and a final decree can be passed in terms of Ext.C1 series. The Advocate Commissioner with the assistance of

Surveyor measured out the plaint schedule property. Thus, the property was found to be partible. As per this report and plan;

- 1) 1/3<sup>rd</sup> share of the plaint schedule property having an extent of 23.750 cents, marked as **“RLMNOPQR”** in the plan attached with the commission report, is allotted to the plaintiff in OS 40/1997.
- 2) 1/3<sup>rd</sup> share of the plaint schedule property having an extent of 23.750 cents, marked as **“gKJhg”** in the plan attached with the commission report, is allotted to the 1<sup>st</sup> defendant in OS 40/1997.
- 3) 1/3<sup>rd</sup> share of the plaint schedule property having an extent of 23.750 cents, marked as **“KLMJK”** in the plan attached with the commission report, is allotted to the 2<sup>nd</sup> defendant in OS 40/1997.
- 4) 1/2 share of the plaint schedule property in OS 365/1996 having an extent of 36.625 cents, marked as **“fghIDdef”** in the plan attached with

the commission report, is allotted to the plaintiff in OS 365/96.

- 5) 1/2 share of the plaint schedule property in OS 365/96 having an extent of 36.625 cents, marked as “**abcdefa**” in the plan attached with the commission report, is allotted to the defendant in OS 365/96.

**In the result, IA allowed and a final decree for partition is passed as follows:**

- 1) 1/3<sup>rd</sup> share of the plaint schedule property in OS 40/1997 situate in survey 432/13, block No.8 of Thrickodithanam Village having an extent of 23.750 cents, marked as “**RLMNOPQR**” in the plan attached with the commission report, is allotted to the plaintiff in OS 40/1997.
- 2) 1/3<sup>rd</sup> share of the plaint schedule property in OS 40/1997 situate in survey 432/13, block No.8 of Thrickodithanam Village having an extent of 23.750 cents, marked as “**gKJhg**” in the plan

attached with the commission report, is allotted to the 1<sup>st</sup> defendant in OS 40/1997.

- 3) 1/3<sup>rd</sup> share of the plaint schedule property in OS 40/1997 situate in survey 432/13, block No. 8 of Thrickodithanam Village having an extent of 23.750 cents, marked as "**KLMJK**" in the plan attached with the commission report, is allotted to the 2<sup>nd</sup> defendant in OS 40/1997.
- 4) 1/2 share of the plaint schedule property in OS 365/96 situate in survey 432/13, block No. 8 of Thrickodithanam Village having an extent of 36.625 cents, marked as "**fghIDdef**" in the plan attached with the commission report, is allotted to the plaintiff in OS 365/96.
- 5) 1/2 share of the plaint schedule property in os 365/96 situate in survey 432/13, block no. 8 of Thrickodithanam village having an extent of 36.625 cents, marked as "**abcdefa**" in the plan attached with the commission report, is allotted to the defendant in OS 365/96.

- 6) Parties are allowed to take separate possession of the shares by metes and bounds by having recourse through execution proceedings before Court of law.
- 7) Ext.C1(a) plan shall form part of the decree.
- 8) Parties are directed to remit requisite amounts for purchasing stamp paper to engross the final decree within 3 months from today, failing which records shall be consigned to the record section.
- 9) Parties shall bear their respective costs.
