This petition coming on this day for hearing before me in the presence of Sri. V. K Satheesh, Advocate for the petitioner, and of Sri.Shaju. K.P Addl. Govt. Pleader for the respondent Nos. 1 to 3 and of Sri. Abdussalam Kolakanni, Advocate for the respondent Nos. 4 and 5, the court passed the following:

ORDER

Petitioner is the 1st claimant in LAR.11/2025. This petition is filed to transfer the Award amount as fixed deposit.

2. Petitioner/first claimant filed affidavit stating that the Competent Authority acquired the property of claimants and an amount of Rs.2,52,86,208/- (Rupees two crore fifty two lakh Eighty six thousand two hundred and eight only) was awarded as compensation. It is further submitted that other claimants raised objection for disbursing the award

amount. The counsel for the petitioner argued that if the award amount is kept idle, the interest over the amount will loss to the interested parties.

3. Heard both sides.

4. I am of the view that some time will require to dispose this LAR. At the same time, if the award amount is kept idle for a long time, it would cause heavy financial loss to the interested parties as interest.

5. Hence, this I.A. is allowed and it is ordered that the amount deposited in this Authority for Rs.2,52,86,208/- (Rupees two crore fifty two lakh Eighty six thousand two hundred and eight only) shall be deposited in Sub Treasury, Manjeri for five years. I.A. allowed accordingly.
