This Suit coming on this day for hearing before me in the presence of Sri. K.V. Sabir and Smt. Amrithadas. K.P Advocates for the plaintiff and of Smt. Anagha. P.A, Smt. Fathima Jishin and Smt. Najiva, Advocates for the defendants, the Court delivered the following:

JUDGMENT

The suit is filed for partition and separate allotment of plaintiff's share over plaint schedule property. During the pendency of the suit parties entered into a compromise and IA.No.02/2026 is also filed. In the result, the final decree for partition is passed as follows:

- 1) 'A' schedule item No.1 is allotted in compromise IA.No.02/2026 favour of the plaintiff.
- 2) 'A' schedule item No.2 in compromise IA.No.02/2026 is allotted in favour of the 1st defendant.
- 3) 'A' schedule item No.3 in compromise IA.No.02/2026 is allotted in favour of defendants No.2, 3 and 6 jointly.

- 4) 'A' schedule item No.4 in compromise IA.No.02/2026 is allotted in favour of the 4th defendant.
- 5) 'A' schedule item No.5 in compromise IA.No.02/2026 is allotted in favour of the 5th defendant.
- 6) 'A' schedule item No.6 in compromise IA.No.02/2026 is allotted in favour of the 8th defendant.
- 7) 'A' schedule item No.7 in compromise IA.No.02/2026 is allotted in favour of the 9th defendant.
- 8) 'A' schedule item No.8 in compromise IA.No.02/2026 is allotted in favour of the 10th defendant.
- 9) 'A' schedule item No.9 in compromise IA.No.02/2026 is allotted in favour of the 11th defendant.
- 10) 'A' schedule item No.10 in compromise IA.No.02/2026 is allotted in favour of the 12th defendant.
- 11) 'A' schedule item No.11 in compromise IA.No.02/2026 is allotted in favour of 13th defendant.
- 12) 'A' schedule item No.12 in compromise IA.No.02/2026 is allotted in favour of 14th defendant.
- 13) 'A' schedule item No.13 in compromise IA.No.02/2026 is allotted in favour of 15th defendant.
- 14) 'A' schedule item No.14 in compromise IA.No.02/2026 is allotted in favour of defendants No.16, 17, 18 and 19 jointly.
- 15) I.A 'B' schedule item No.1 in compromise IA.No.02/2026 is allotted in favour of defendants No.8 to 19 jointly.
- 16) I.A 'B' schedule item No.2 in compromise IA.No.02/2026 is allotted in favour of plaintiff and defendants No.1 to 6 jointly.
- 17) Compromise I.A. 02/2026 and plan shall form part of the decree.
- 18) The parties are directed to produce chalan for purchasing non judicial stamp paper for engrossing the decree on stamp paper within two months from the date of decree. If not, consign to record room.

- 19) On engrossing Final Decree on stamp paper, a copy of the same shall be transmitted to SRO concerned.
