This application is filed under Order 38, Rule 5 of the Civil Procedure Code, read with section 9 of the Arbitration and conciliation Act 1996 to pass an order of attachment of petition schedule property and direct the respondents to furnish security to the tune of ₹60,000/- (Rupees sixty thousand only), with in a stipulated time and in case of default make the order of attachment absolute.

This Interlocutory Application having been heard on 06.02.2026 and this court on the same day passed the following:-

ORDER

The petition is for an order of conditional attachment of the petition schedule property.

2. Heard the learned counsel for the petitioner and perused the records. I am satisfied that the second respondent is trying to alienate / transfer / dispose of the petition schedule property with an intention to delay / defeat the execution of any award / decree, that may be passed in the above proposed arbitration proceedings. Hence, issue notice to the respondents to show-cause why they shall not furnish security to the tune of ₹60,000/- (Rupees sixty thousand only). Meanwhile, there shall be an order of conditional attachment of the petition schedule property.

3. Issue attachment order. Communicate this order to the Sub Registrar's office concerned. Issue notice. Return of notice and return of attachment order, call on 06.03.2026.
