This application is filed under Order 38, Rule 5 of the Civil Procedure Code, read with section 9 of the Arbitration and conciliation Act 1996 to pass an order of attachment of petition schedule property and direct the respondents to furnish security to the tune of ₹16,15,162/- (Rupees sixteen lakhs fifteen thousand one hundred and sixty two only) with in a stipulated time and in case of default make the order of attachment absolute.

ORDER

I am satisfied that the respondents are trying to alienate / transfer / dispose of the petition schedule property with an intention to delay / defeat the execution of any award / decree, that may be passed in the above proposed arbitration proceedings. Hence, issue notice to the respondents to show-cause why they shall not furnish security to the tune of ₹16,15,162/- (Rupees sixteen lakhs fifteen thousand one hundred and sixty two only). Meanwhile, there shall be an order of conditional attachment of the petition schedule property.

3. Issue attachment order. Communicate this order to the Sub Registrar's office concerned. Issue notice. For return of

notice and return of attachment order, call on 06.01.2026.
