This suit coming on this day for final hearing before me in the presence of Sri. V. Rajan, Advocate for plaintiff, and the defendants are called; absent; set ex parte, and this court passed the following:-

JUDGMENT

This is a suit for money.

2. The plaintiff's case, in brief, is as follows:-

The plaintiff is a company offering financial services. The 1st defendant applied to the plaintiff for a loan of ₹ 25,000/- on 02.10.2024, and the plaintiff sanctioned the loan on the same day. The 2nd defendant is the guarantor on the loan. The defendants signed a loan agreement when the plaintiff sanctioned the loan . The agreement was that the defendants

would repay the loan with 18% interest per annum . The defendants have only repaid ₹ 25,700/- so far .They have defaulted on the loan and owe the plaintiff ₹ 34,362/- as of the date of presentation of the plaint. The plaintiff is entitled to recover that sum from the defendants with 18% interest per annum

3. The defendants were served with summonses, but they did not come to court to defend the suit. Therefore, the suit was heard ex parte.

4. The plaintiff's executive director was examined as PW1, and the documents submitted in evidence by the plaintiff were marked as Exts.A1 to A3.

5. Heard the plaintiff's counsel .

6. PW1 testified in tune with the contents of the plaint. Ext. A1 is the loan agreement signed by the defendants, and Ext.A2 is the promissory note signed by them .PW1's testimony and the documents submitted in evidence prove the plaintiff's case. Therefore, the suit is decreed as follows :-

1. The defendants are ordered to pay the plaintiff ₹ 34,362/- ,and interest thereon at the rate of 12 % per annum from the date of the suit to the date of the decree and 6% per annum from the date of the decree to the date of payment.
2. The defendants are ordered to pay the plaintiff's costs.
