This suit coming on this day for final hearing before me in the presence of Sri.P.Jayan and Smt.Devika.K.G., Advocates for the plaintiff, and the defendant is called; absent; set ex parte, and this court passed the following:

JUDGMENT

This is a suit for money.

2. The plaintiff's case, in brief, is as follows:-

The plaintiff is a purveyor of stainless steel pipes. The defendant bought pipes worth of ₹ 3,49,077/- from the plaintiff and owes it ₹ 15,025/- . The plaintiff is entitled to recover ₹ 15,025/- from the defendant with 12% interest per annum from the date of the suit to the date of payment.

3. The defendant was served with a summons , but he did not come to court to defend the suit. Therefore, the suit was heard ex parte.

4.The proprietor of the plaintiff was examined as PW1, and the documents submitted in evidence by the plaintiff were marked as Exts.A1 and A2.

5. Heard the plaintiff's counsel.

6. PW1 testified in tune with the contents of the plaint. Exts.A1 (a) to A1 (q) are copies of the invoices raised to the defendant , and Ext.A2 is a statement showing the transactions between the plaintiff and defendant. PW1's testimony and the documents submitted in evidence prove the plaintiff's case. Therefore, the suit is decreed as follows :-

1. The defendant is ordered to pay the plaintiff ₹ 15,025/- ,with 12% interest per annum from the date of the suit to the date of the decree and 6% interest per annum from the date of the decree to the date of payment.
2. The defendant is ordered to pay the plaintiff's costs.
