ORDER

The accused is put on trial for the offence punishable under Sections 126(2),115(2), 118(1), 110 of Bharatiya Nyaya Sanhitha, 2023 in Crime No. 654/2025 by the Inspector of Police, Kozhinjampara Police Station.

2. The prosecution case in brief are as follows :At 12.45 P.M. on 03.09.2025 the accused with intention to commit bodily hurt to defacto complainant, wrongfully restrained him at a place named 6th mile and stabbed in the left eye of the defacto complainant with his hand and beat him with a wooden stick which if used as a weapon of offence is a dangerous weapon, on his back side and right elbow. Thereafter when the

accused again tried to beat on his head, the defacto complainant evaded that blow. Had he not evaded that blow it might have hit his head which might have caused his death and thereby the accused committed the above said offence.

3. During the course of investigation the accused was arrested and produced on 05.09.2025 and later the accused was granted bail as per the order of Hon'ble Court of Session, Palakkad in CrI. MC No. 4819/2025 and he was released on 18.10.2025.

4. After filing final report in this case this court has taken the file as CP 23/2026 and summons was issued to the accused. The accused was in judicial custody in another case and was produced on production warrant from High Security Prison, Viyyur through video conferencing. Permitted to continue on bail. Copies of prosecution records was given to him under section 230 of The Bharatiya Nagarik Suraksha Sanhita. The accused is alleged to have committed offence punishable under Sections 126(2), 115(2), 118(1), 110 of Bharatiya Nyaya Sanhitha, 2023 out of which Section 110 of Bharatiya Nyaya Sanhita is exclusively triable by a Court of Sessions.

5. Hence the case against the accused is committed to the Hon'ble Court of Sessions, Palakkad under Section 232 of The Bharatiya Nagarik Suraksha Sanhita.

1. Accused who is on bail in this case is directed to appear before Hon'ble Court of Session, Palakkad, as and when directed. Production warrant is

recalled for the time being and Superintendent, High Security Prison, Viyyur is directed to produce him before Hon'ble Sessions Court, Palakkad if he continues the custody in the other case and if production warrant is issued from Hon'ble Sessions Court, Palakkad in this case.

2. Submit the records of this case to the Hon'ble Court of Sessions, Palakkad.
3. The committal of this case should be notified to the Public Prosecutor, Palakkad under Section 232 (d) of The Bharatiya Nagarik Suraksha Sanhita.
4. The thondy articles/property if any in this case should be produced before Hon'ble Court of Sessions, Palakkad, as and when directed.
