J U D G M E N T

Suit for permanent prohibitory injunction.

2. The plaintiff filed the suit for permanent prohibitory injunction restraining the defendants from trespassing and obstructing the peaceful possession and enjoyment of plaintiff's property by the plaintiff and also from causing damage to the same. The cause of action for the suit arose on 3.3.2014 and thereafter within the jurisdiction of this Court.

3. On 12.11.2015, defendants were called absent, set aside. The plaintiff was examined as PW1 and Exts.A1 to A6 were marked.

4. The unchallenged testimony of PW1 and Exts.A1 to A6 proves the case of plaintiff and his entitlement for a decree as prayed for.

In the result, suit is decreed as follows:

1) That the defendants are hereby restrained by a permanent prohibitory injunction from trespassing and obstructing the peaceful possession and enjoyment of plaintiff's property by the plaintiff and also from causing damage to the same.

2) That plaintiff is also entitled to get cost of the suit.
