ORDER

This is a petition filed u/s. 23 of the Protection of Women from Domestic
Violence Act, 2005.

2. Heard. Perused the affidavit and petition. Prima facie allegations are made out

that the respondent has committed acts of domestic violence against the petitioner. Issuance of urgent notice will not serve the purpose. Hence, the petition is allowed in part and an ad-interim protection order is allowed until further orders as follows;

- The respondent is restrained from entering into the parental house of the first petitioner bearing house No.13/656 of Kizhakkanchery Gramapanchayat, from threatening the first petitioner and her relatives over phone, from entering into Cherupushpam Girls Higher Secondary School, Vadakkanchery, and from forcibly taking the third minor petitioner from the custody of the first petitioner without her consent, until further orders.
- S.H.O. Vadakkanchery Police Station shall give necessary assistance to the petitioner in the implementation of the order on the production of a copy of the order.
- Serve a copy of this order to the petitioner and respondent free of cost.
- Issue notice to the respondent.
