Provision of Law } Punishable u/s. 23 of the Protection
of Women from Domestic Violence

ORDER

This is a petition filed u/s. 23 of the Protection of Women from Domestic Violence Act, 2005.

2. Heard. Perused the affidavit and petition. Prima facie allegations make out that the respondents have committed acts of domestic violence against the petitioner. Issuance of an urgent notice will not serve the purpose. Hence, the petition is allowed,

and an ad-interim protection and residence order is allowed until further orders as follows;

- The respondents are restrained from committing, aiding, or abetting in the commission of any acts of domestic violence against the petitioner u/s.18 of the P.W.D.V Act, until further orders.
- The respondent is restrained from disturbing the peaceful possession and enjoyment of the petitioner in the petition schedule property comprised in 0.0265 of land and a house bearing door No.PP/10/286 in R.sy No.418/15 (old Sy No.39 B/1), 3, block No. 33 of Puthukkode Gramapanchayat, and restrained the respondents or any of their relatives from entering therein u/s.19 of the P.W.D.V Act, until further orders.
- S.H.O. Vadakkanchery Police Station shall give necessary assistance to the petitioner in the implementation of the order on the production of a copy of the order.
- Serve a copy of this order to the petitioner and respondents free of cost.
- Issue notice to the respondents.
