ORDER

This is a petition filed u/s. 23 of the Protection of Women from Domestic Violence Act, 2005.

2. Heard. Perused the affidavit and petition. Prima facie allegations make out that the respondent has committed acts of domestic violence against the petitioners. Issuance of an urgent notice will not serve the purpose. Hence, the petition is allowed,

and an ad-interim protection and residence order is allowed until further orders as follows;

- The respondent is restrained from committing, aiding, or abetting in the commission of any acts of domestic violence against the petitioners u/s.18 of the P.W.D.V Act, until further orders.
- The respondent is restrained from disturbing the peaceful possession and enjoyment of the petitioners in the petition schedule property comprised in 4 cents of land and a house bearing door No.41 in Ward No.12, R.sy No. 458/4, block No. 25 of Melarcode Panchayat, u/s.19 of the P.W.D.V Act, until further orders.
- S.H.O. Alathur Police Station shall give necessary assistance to the petitioner in the implementation of the order on the production of a copy of the order.
- Serve a copy of this order to the petitioners and respondent free of cost.
- Issue notice to the respondent.
