ORDER

The accused are charge sheeted for the offences punishable u/ss.126(2),
115(2), 118(1), 110 r/w 3(5) of the Bharatiya Nyaya Sanhita, 2023 in Crime

No.1413/2025 of Vadakkanchery Police Station.

2. The prosecution case, in brief, is that on 14.12.2025 at 21.00 hours, at Manappadam, Kanakkannur, due to political vengeance, accused No.1 to 4 wrongfully restrained the de facto complainant. Accused No.1, with the intention to commit culpable homicide, hit the de facto complainant's head with a stone and inflicted injury on the left side of his head. In the same transaction, accused No.1 to 4 beat the de facto complainant's relatives with their hands, pelted stones towards them and inflicted injuries on them. If the de facto complainant could not evade the assault of the accused with the stone, he might have sustained grievous injury on his head, resulting in his death. It is alleged that the accused shared their common intention in committing the abovesaid offences. Thus, the accused are alleged to have committed the above-mentioned offences.

4. Accused No.1 and 3 were arrested and produced before this court on 15.12.2025 and on the same day, they were released on bail as per the order in CMP 4464/2025 of this court. Accused No.2 and 4 were arrested and produced before this court on 17.12.2025 and on the same day, they were released on bail as per the order in CMP 4484/2025 of this court. Copies of relevant prosecution records were furnished to the accused under sec. 230 B.N.S.S. After hearing both sides and from the records, it appears that this case is exclusively triable by a Court

of Sessions. Hence, the following orders are passed.

1. The case against the accused is committed to the Hon'ble Sessions Court, Palakkad as u/s. 232 (a) B.N.S.S.
2. The accused are directed to appear before the Hon'ble Sessions Court as and when directed u/s. 232 (b) B.N.S.S.
3. Submit the entire records of the case, documents and the properties to the Hon'ble Sessions Court u/s.232 (c) B.N.S.S as and when required.
4. The committal of the case shall be notified to the Public Prosecutor u/s. 232 (d) B.N.S.S.
