ORDER

The accused is charge sheeted for the offences punishable u/ss. 118 (1) and 110 of the Bharatiya Nyaya Sanhita, 2023 in Crime No.1148/2025 of Alathur Police Station.

2. The prosecution case, in brief, is that on 19.10.2025 at 13:00 hours, in front of the Beverages outlet in Thrippalur, a wordy quarrel between the accused and the de facto complainant occurred. Infuriated by this, the accused voluntarily caused hurt to the de facto complainant by stabbing him above his left ear with a knife. If the

accused stabbed the de facto complainant's neck or somewhere else, he might have sustained grievous injury resulting in his death. Thus, the accused is alleged to have committed the above-said offences.

3. Accused was arrested and produced before this court on 20.10.2025 and was remanded to judicial custody. He was released on bail as per the order in Criminal Miscellaneous Case No. 5130/2025 dated 21.11.2025 of the Hon'ble Sessions Court, Palakkad. Copies of relevant prosecution records were furnished to the accused under sec. 230 B.N.S.S. After hearing both sides and from the records, it appears that this case is exclusively triable by a Court of Sessions. Hence, the following orders are passed.

1. The case against the accused is committed to the Hon'ble Sessions Court, Palakkad as u/s. 232 (a) B.N.S.S.
2. The accused is directed to appear before the Hon'ble Sessions Court as and when directed u/s. 232 (b) B.N.S.S.
3. Submit the entire records of the case, documents and the properties to the Hon'ble Sessions Court u/s.232 (c) B.N.S.S as and when required.
4. The committal of the case shall be notified to the Public Prosecutor u/s. 232 (d) B.N.S.S.
