ORDER

This case is charge sheeted by the Inspector of Police, Nenmara P.S in crime No.577/2025 for the offences punishable U/ss.126(2), 118(1), 333, 110, 351(2), 238 (c) of B.N.S.

2. The prosecution allegation is that on 12.08.2025 between 23.20 hours and 23.40 hours, at Chittur Taluk, Nenmara Village, XIV Ward, at Chathamangalam-Kallankode, the accused, who is a relative of CW3, trespassed into the two storied

RC house bearing No. XIV/814 belonging to CW3 (father of CW1), and while CW2 was talking inside the house, the accused, with intention and preparation to commit offence, armed with a deadly weapon (knife), threatened CW1 with death, directed CW1 to leave the house, and thereafter trespassed into the sit-out of the house and caught hold of CW1 by pulling the hair and restrained CW1, and caused injury by cutting CW1 on the left hand muscle portion with the knife, thereby causing a deep incised wound, and further attempted to assault again with the knife and but for CW1 moving away, CW1 would have sustained stab injury on chest/head resulting in death, and thereafter the accused concealed the weapon and caused disappearance of evidence. Thus, the accused is alleged to have committed the above mentioned offences.

3. The accused was granted anticipatory bail as per the order in Criminal Miscellaneous Case No. 4523/2025 of the Hon'ble Sessions Court, Palakkad. On appearance of the accused on summons, he was released on bail as per order in Criminal Miscellaneous Petition No. 1/2026 dated 18.02.2026 of this court. Copies of relevant prosecution records were furnished to him under sec. 230 of BNSS. After hearing both sides and from the records it appears that this case is exclusively triable by a Court of Sessions. Hence the following orders are passed.

1. The case against the accused is committed to the Hon'ble Sessions Court, Palakkad as u/s. 232(a) BNSS.

2. The accused is directed to appear before the Hon'ble Sessions Court as and when directed u/s.232(b) BNSS.
3. Submit the entire records of the case, documents and the properties to the Hon'ble Sessions Court U/s 232(c) BNSS.
4. The committal of the case shall be notified to the Public Prosecutor u/s 232(d) BNSS.
