This Petition is coming on for hearing on 18.09.2025 and the Court on the same day passed the following:

ORDER

Heard both sides. The counsel for the respondent/appellant submitted that objection filed to this petition. But on verification of

records it can be seen that no counter filed to this petition. Perused the petition and the order passed in IA.No. 2/2024. In the petition it is stated that the said order is passed without considering the objection and hearing on his side, so there is error apparent on the face of the record. My learned predecessor in office passed the order in IA 2/2024 as "Heard, allowed". This court can not make a finding that my learned predecessor in office passed the order without hearing and considering the objection of the petitioner/respondent and there is error apparent on the face of the record. The remedy available to the petitioner/respondent is only to challenge the order in IA.No. 2/2024 before the appropriate authority. Therefore, there is no merit in the petition. Hence petition dismissed.
