This case was finally heard on 18-03-2026, and this court, on the same day delivered the following

JUDGMENT

This case is charge-sheeted against the accused by the sub inspector of police, Perunadu police station in crime number 95/2024 under sections 294(b), 324 and 506(i) of IPC.

2. Prosecution allegation in brief is as follows:-On account of animosity of the accused against CW1-Mohandas, on 26/02/2024 at 23.55 hrs, on the Maniyar-Perunadu public road at Kizhakke Mampara, in Perunadu Village, the accused Rajesh.R with the intention and preparation to cause bodily injury to Mohandas, uttered obscene words against Mohandas, threatened to break his disabled leg and beat on his head with a wooden plank causing injury to his head and left hand. Thus, the accused is alleged to have committed the offences under the aforesaid sections of IPC.

3. On the appearance of the accused, copies of all prosecution documents were served on him. The accused was granted bail. After hearing on framing charge, the charge was framed against the accused for the offences punishable under sections 294(b), 324 and 506(i) of IPC, read over and explained to the accused, to which he pleaded not guilty and claimed to be tried.

4. Evidence of the prosecution, in this case, consists of the oral testimony of PW1 and the documentary evidence comprised of

Ext.P1. After prosecution witnesses was examined, no incriminating circumstances appeared in prosecution evidence against the accused and hence examination under section 351(1)(b) of BNSS was dispensed with. No evidence is adduced from the side of the defence.

5. Heard the learned Assistant Public Prosecutor and counsel for the accused.

6. **The following points arise for consideration in this case:-**

- i. Has the prosecution proved its case beyond reasonable doubt against the accused?
- ii. What shall be the sentence or the order, if any, to be passed against the accused?

7. **Points No (i) :-** Mohandas, the sole injured in the case, is examined as PW1. He stated that he was injured at the incident in this case at Kizhake Mambara. He did not remember the date and time of the incident. He admits that Ext.P1 is the FIS given by him to the police. He has turned hostile to the prosecution and stated that the accused present in the court has not injured him. The other witnesses are given up by the APP. As the available evidence is not sufficient to establish the guilt of the accused, I have no option other than to answer this point against the prosecution. Thus, the point (i) is found against the prosecution.

8. **Point no (ii):-** In view of the finding in point number (i) to (iii), the prosecution has failed to prove the guilt of the accused. Point number (ii) does not arise for consideration.

In the result, the accused is found not guilty of the offences under sections 294(b), 324 and 506(i) of IPC. He is acquitted under section 271(1) BNSS of the said offences. The bail bond executed by the accused stands cancelled and he is set at liberty.
