ORDER

This is a petition under Order 41 Rule 5 r/w Section 151 of CPC with a prayer to extend the stay in the operation of decree dated 24.09.2023 in O.S.60/2014 of Sub Court, Chavakkad.

2. Heard counsel for the petitioners and perused the records. Stay of impugned decree is already granted as per order in I.A.1/2024 on 24.11.2023. Thereafter as per order dated 19.08.2024 in I.A.3/2024 the stay is extended till 18.11.2024. In view of the averments in the present affidavit and upon hearing counsel for the petitioners I found that there are sufficient grounds to extend the stay already granted for a further period of three months. Hence petition allowed.

3. Accordingly stay already granted is extended for a further period of three months. Petition allowed as above.
