This petition is coming on this day for hearing, the court passed the following:-

**ORDER**

This is a petition under Section 151 of the Code of Civil Procedure with a prayer to extent the stay already granted in IA 1/2024. The petitioner is the appellant herein. As per Order dated 23.02.2024 in IA 01/2024 in AS 26/2024, the operation of impugned judgment and decree dated 24.11.2023 in OS 60/2024 of Sub Court, Chavakkad is stayed. In the present petition the petitioner prayed to extent the stay till the disposal of the appeal.

2. Notice given to the respondent. The respondent opposed the petition by filing the counter statement.

3. I have heard both sides and perused the records.

4. As mentioned in previous order at this stage prima facie I am satisfied that, the appellant have good case to argue in appeal. Hence stay already granted on 23.02.2024 as per Order in IA 01/2024 in AS 26/2024. Therefore this court of the view that, at present there is no legal or factual grounds to withdraw the stay already granted. Therefore stay already granted as per order in IA 1/2024 on 23.02.2024 is extended until further orders. The petition is allowed accordingly.
