This petition is coming on for hearing and the same day the court passed the following:

**ORDER**

This is a petition filed by the petitioner/1<sup>st</sup> respondent in CrI. Appeal No.225/2022 for directing the Judicial Magistrate of First Class Court – I, Thrissur for releasing an amount of Rs.1,70,000/-, which was remitted by the respondent/appellant in obedience to order in CrI.MP.No.3264/2022 dated 19.10.2022, in view of the mediation agreement entered into between the parties .

2. No objection for the respondent. Heard both sides.

3. As per order dated 19.10.2022 in CrI.MP.No.3264/2022 in CrI.A.No.225/2022, the respondent/appellant was directed to deposit 20% of the fine amount ordered by the trial court before that court, for the purpose of suspending the

sentence. According to both sides, the respondent has remitted an amount of Rs.1,70,000/- before that court. As per the mediation agreement dated 29.04.2026, entered into between the parties, they have agreed that the petitioner herein is entitled to get the said amount from the Judicial Magistrate of First Class Court – I, Thrissur. Being so, the petition has to be allowed.

In the result, the petition is allowed. Judicial Magistrate of First Class Court – I, Thrissur is directed to release an amount of Rs.1,70,000/-, which was remitted by the respondent herein/the accused in CC.No.3687/2015 in obedience to the order dated 19.10.2022 in Crl.MP.No.3264/2022 in Crl.Appeal No.225/2022 to the petitioner herein/complainant in CC No.3687/2015.
