This petition is filed under Section 151 of CPC to stay all further proceedings in O.S.363/2024 of Munsiff Court, Irinjalakuda and O.S.32/2025 of Sub Court, Irinjalakuda till the disposal of this transfer petition.

This petition is coming on this day for hearing, the court passed the following:-

ORDER

This is a petition under Sec.151 of CPC with a prayer to stay the proceedings in O.S.363/2024 of Munsiff Court, Irinjalakuda and O.S.32/2025 of Sub Court, Irinjalakuda.

The brief statement of facts are, the petitioners herein filed TOP under Section 24 of CPC to transfer of O.S.363/2024 of Munsiff Court, Irinjalakuda for joint trial with O.S.32/2025 pending before Sub Court, Irinjalakuda. It is contended that, both suits are with respect to same property, so the subject matter of both suits are one and the same.

3. Having gone through the grounds mentioned in the main O.P. and the present petition and upon hearing the learned counsel for the petitioner at this stage *prima facie* this court satisfied that there are sufficient grounds to have a joined trial of O.S. 363/2024 pending before Munsiff Court, Irinjalakuda and O.S. 32/2025 pending before Sub Court, Irinjalakuda. So if the trial of any of the suits commenced that may detrimentally affect the relief of the petitioner mentioned in the present transfer O.P. Therefore for the time being during the pendency of the transfer O.P. for a period of three months the trial of the above suits are stand stayed. It is made clear that the stay is only for commencement of the trial but no stay for taking any pre-trial steps and

proceeding with the suits till the trial. Hence the petition is allowed as mentioned above.
