ORDER

This case is charge sheeted by the Sub Inspector of Police, Ollur in Crime No. 671/25 of Ollur Police Station against the accused persons, alleging commission of offences punishable under sections 333, 115(2), 118(1), 351(3), 110, 238, 3(5) of BNS.

2. The prosecution case in brief is as follows: On 22/04/2025 at 11.35 a.m. the accused persons 1 to 4, in furtherance of their common intention, due to previous enmity towards the defacto complainant's brother in laws, with respect to the misunderstanding that

the complainant's brother in laws had teased the accused persons, criminally trespassed into the Meenutty Chicken Centre at Ancherichira, conducted by the defacto complainant. 1st accused who barged into the shop with a knife, tried to stab the brother in laws, then the complainant defended him and during the struggle the complainant sustained cut injury on his right thumb finger and he fell down on the floor. 2nd accused fisted on the face of the defacto complainant, 3rd accused criminally intimidated the people who were standing in the shop and 4th accused kicked him with legs. If the defacto complainant would not have taken self defence at the time of attack by the 1st accused towards him as well as his brother in laws, it would have resulted in their death. It is thereby contended that the accused persons are alleged to have committed the aforesaid offences.

3). Accused persons 1 to 3 are on bail. A4 is still in remand. Copies of relevant records were furnished to them. After hearing both sides and from the records it appears that the offence alleged against the accused persons is exclusively triable by a Court of Session. Hence the case is committed to the Hon'ble Sessions Court, Thrissur U/s. 232(a) of BNSS.

4). A1 to A3 are enlarged on bail and they are directed to appear before the Hon'ble Sessions Court, Thrissur and the Jail Superintendent is directed to produce the accused before the court as and when directed as u/s 232(b) of BNSS.

5). Submit the entire records of the case, documents and the properties to the Hon'ble Sessions Court U/s 232(c) of BNSS.

6). The committal of the case shall be notified to the Public Prosecutor u/s 232(d) of BNSS.
