ORDER

Petition filed by the counsel for accused No.13.

- The averments in the petition are as follows:** The petitioner is the 13th accused in the above case. The offences alleged against the petitioner are under Sections 120B, 406, 468, 420 r/w 34 of the Indian Penal Code and sections 4, 5 and 6 of the Prize Chits and Money Circulation Schemes (Banning) Act, 1978.

Petitioner was granted bail in the above case as per order in CMP 1/2026 dated 22/04/2026 as per conditions and the third condition imposed was that, the petitioner shall not leave Thrissur District without the prior permission of this court. Petitioner's permanent place of residence is in Hyderabad and her two minor daughters and her father-in-law whose leg is amputated are residing there. Petitioner having been here for more than two months. There is no one to look after the aged father-in-law and daughters of the petitioner, other than the petitioner. After the completion of vacation, petitioners daughters' school is resuming on 1/6/2026. Hence, it is necessary to lift the condition imposed on the petitioner not to leave the Thrissur District, and to permit her to go to Hyderabad for providing parental attention and supervision to her young children and to assist her ailing father-in-law who needs her support. Petitioner will strictly abide by all other bail conditions imposed on her and will appear before the court, as and when directed. Hence, this petition is to lift the third condition in the bail order.

2. Report filed through the learned APP opposing the application on the ground that if the petition is allowed, the petitioner will go absconding.
3. Heard.
4. CMP 1/2026 was allowed by this court on 28/04/2026 subject to conditions. The Condition No. iii in the bail order is that *"Petitioner shall not leave Thrissur District without the prior permission of this Court"*. Now, the petitioner seeks permission to lift the condition no.(iii)

5. Considering the lapse of time after the passing of the bail order and since it will take time to complete the trial and dispose of the case, it is not just and proper to impose this condition any further. Hence, the petition is allowed. The condition No.iii stands lifted.

In the result, CMP is allowed.
