This case having been heard finally on the 23rd day of March 2026
the court on the same day delivered the following:-

COMMITTAL ORDER

1. The Excise Inspector, Irinjalakuda Range filed charge sheet in
Crime No. 95/2025 of that Range against accused for the offences
punishable under sections 55(i) of the Kerala Abkari Act I of 1077.

2. The prosecution case in brief is that, on 04.07.2025 at
10:00 p.m. at Amballur desom, the accused was found in illegal
possession of 9 litres of Indian made Foreign Liquor, for ready sale.
Thus, the accused is alleged to have committed the above said offence.

3. Accused is on bail. Copies of all the relevant prosecution records were furnished to the accused u/s. 230 of BNSS. After hearing both sides and on perusal of the records it is noticed that the offences alleged to be committed by the accused herein are exclusively triable by a Court of Sessions. Hence the case is committed to the Hon'ble Court of Sessions, Thrissur u/s. 232 (a) BNSS.

4. The accused who is on bail, is directed to appear before the Hon'ble Sessions Court, Thrissur as and when directed.

5. Submit the entire records of the case and documents to the Hon'ble Sessions Court, Thrissur u/s. 232 (c) BNSS.

7. The committal of the case shall be notified to the Public Prosecutor u/s. 232 (d) BNSS.
