- Offence : U/s. 143,147,148,341,323,324,149 of IPC.
- Finding : Exclusively triable by the Hon'ble Children's Court.
- Sentence or Order : Case is committed to the Hon'ble Children's Court, Thrissur.

This case having been heard finally on the 11th day of March 2026 the court on the same day delivered the following:-

COMMITTAL ORDER

1. This case is taken on file upon a final report filed by the Sub Inspector of police, Kattoor Police Station in Crime No. 864/2017 of that police station against the accused alleging offences punishable under sections 143,147,148,341,323,324,149 of IPC.

2. The prosecution allegation against the accused is as follows:-

Accused along with a child in conflict with law due to previous animosity at 11:30 hours on 07-12-2017 on the road in front of health centre, Valavanangadi, wrongfully restrained CW1. First accused struck him with a granite stone. When CW2 to CW5 interfered, all accused including child in conflict with law restrained them and slapped them. Thus the accused is thereby alleged to have committed the aforementioned offences.

3. Accused No. 4 is absconding. Accused Nos. 1 to 3 appeared before the Court and was enlarged on bail. Copies of relevant prosecution records were furnished to the accused. After the preliminary hearing and on perusing the records, it is found that the injured CW1 is a minor. As per S. 86 substituted by the Amendment Act of 2021 to Juvenile Justice (Care and Protection of Children) Act, 2015, offence against children is to be tried by Honorable Children's Court. Hence the case is refiled as CP 37/2026 and is hereby committed to the Hon'ble Children's Court, Thrissur u/s. 362 of BNSS.

4. The accused who is on bail, is directed to appear before the Hon'ble Children's Court, Thrissur as and when directed.

5. Submit the entire records of the case and documents to the Hon'ble Children's Court, Thrissur.

6. The committal of the case shall be notified to the Public Prosecutor.

7. Case against Accused No. 4 is refiled as CP 40/2026.
