This case having been heard finally on the 11th day of March 2026 the court on the same day delivered the following:-

COMMITTAL ORDER

1. This case is taken on file upon a final report filed by the Sub Inspector of police, Kattoor Police Station in Crime No. 98/2022 of that police station against the accused alleging offences punishable under sections 448,506(ii),427 of IPC.

2. The prosecution allegation against the accused is as follows:-

At 18:00 hours on 30-01-2022, accused due to previous animosity, trespassed in to the verandah of the house of CW1 at

Payammal, showing a chopping knife intimidated to kill CW1, her husband and children and then left from the place. Thereafter at 18:30 hours, accused armed with chopping knife, return back there and using chopping knife destroyed the window glasses and thereby caused a damage to the tune of Rs. 10,700/-. Thus the accused is thereby alleged to have committed the aforementioned offences.

3. Accused appeared before the Court and was enlarged on bail. Copies of relevant prosecution records were furnished to the accused. After the preliminary hearing and on perusing the records, it is found that the injured CW2 and CW3 are minors. As per S. 86 substituted by the Amendment Act of 2021 to Juvenile Justice (Care and Protection of sd/- Children) Act, 2015, offence against children is to be tried by Honorable Children's Court. Hence the case is refiled as CP 30/2026 and is hereby committed to the Hon'ble Children's Court, Thrissur u/s. 362 of BNSS.

4. The accused who is on bail, is directed to appear before the Hon'ble Children's Court, Thrissur as and when directed.

5. Submit the entire records of the case and documents to the Hon'ble Children's Court, Thrissur.

6. The committal of the case shall be notified to the Public Prosecutor.
