COMMITTAL ORDER

1. This case is taken on file upon a final report filed by the Sub
Inspector of Police, Irinjalakuda Police Station in Crime No.413/2025 of
that police station against the accused alleging offences punishable
under section 75(1)(i) of JJ Act and 324(2) of BNS.

2. The prosecution allegation against the accused is as follows:-

On 10-03-2025 at 04:30 pm, in front of the bakery near to St. Antony's School at Pudukkad, due to previous animosity, accused caught hold CW1 and attempted to kiss her and thereby outraged her modesty. Accused threw her mobile phone and thereby caused damage to her mobile phone to the tune of Rs. 5,000/-. Thus the accused is thereby alleged to have committed the aforementioned offences.

3. Accused appeared before the Court and was enlarged on bail. Copies of relevant prosecution records were furnished to the accused. Conducted preliminary hearing and perused the records. As per S. 86 substituted by the Amendment Act of 2021 to Juvenile Justice (Care and Protection of Children) Act, 2015, offence against children is to be tried by Honorable Children's Court. Hence the case is refiled as CP 36/2026 and is hereby committed to the Hon'ble Children's Court, Thrissur u/s. 362 of BNSS.

4. The accused who is on bail, is directed to appear before the Hon'ble Children's Court, Thrissur as and when directed.

5. Submit the entire records of the case and documents to the Hon'ble Children's Court, Thrissur.

6. The committal of the case shall be notified to the Public Prosecutor.
