Finding : Exclusively triable by Court of Sessions.

Sentence or Order : Case is committed to the Hon'ble Sessions Court,  
Thrissur.

This case having been heard finally on the 18<sup>th</sup> day of May 2026 the  
court on the same day delivered the following:-

**COMMITTAL ORDER**

1. This case is taken on file upon a final report filed by the  
Inspector of Police, Kattoor Police Station in Crime No. 1000/2025 of  
that police station against the accused alleging offences punishable  
under sections 126(2),117(3),115(2),105 of BNS.

2. The prosecution allegation against the accused is as follows:-

On 25-10-2025 at 22:30 hours, near to Chembazhanthi  
Auditorium, at Edakkulam, accused wrongfully restrained Jithu (the  
nephew of defacto complainant) and assaulted him. Thereby he

sustained injuries to his kidney and other parts and while he was on treatment at Medical College hospital, Thrissur, he succumbed to the injuries. Thus, the accused is alleged to have committed the aforementioned offences.

3. Accused is on bail. Copies of all the relevant prosecution records were furnished to the accused u/s. 230 of BNSS. After hearing both sides and on perusal of the records it is noticed that the offences alleged to be committed by the accused herein are exclusively triable by a Court of Sessions. Hence the case is committed to the Hon'ble Court of Sessions, Thrissur u/s. 232 (a) BNSS.

4. The accused is directed to appear before the Hon'ble Sessions Court, Thrissur as and when directed.

5. Submit the entire records of the case and documents to the Hon'ble Sessions Court, Thrissur u/s. 232 (c) BNSS.

6. The committal of the case shall be notified to the Public Prosecutor u/s. 232 (d) BNSS..
