This case having been heard finally on the 11<sup>th</sup> day of March 2026 the court on the same day delivered the following:-

**COMMITTAL ORDER**

1. This case is taken on file upon a final report filed by the Sub Inspector of police, Kodakara Police Station in Crime No. 1096/2025 of that police station against the accused alleging offences punishable under sections 281, 125(a) of BNS.

2. The prosecution allegation against the accused is as follows:-

On 15-12-2024 accused drove autorickshaw bearing registration No. KL-64-D-0186 through Mechira – Kanakamala road from east to

west direction in a rash and negligent manner so as to endanger human life and when the vehicle reached near to Anganvadi near Kanakamala palli at 09:00 hours, it hit on a parked car (bearing registration No. KL-64-F-6203) on the road side. Thereby CW2 and CW3, who were the passengers of the autorickshaw sustained injury. Thus the accused is thereby alleged to have committed the aforementioned offences.

3. Accused appeared before the Court and was enlarged on bail. Copies of relevant prosecution records were furnished to the accused. After the preliminary hearing and on perusing the records, it is found that the injured CW2 and CW3 are minors. As per S. 86 substituted by the Amendment Act of 2021 to Juvenile Justice (Care and Protection of Children) Act, 2015, offence against children is to be tried by Honorable Children's Court. Hence the case is refiled as CP 30/2026 and is hereby committed to the Hon'ble Children's Court, Thrissur u/s. 362 of BNSS.

4. The accused who is on bail, is directed to appear before the Hon'ble Children's Court, Thrissur as and when directed.

5. Submit the entire records of the case and documents to the Hon'ble Children's Court, Thrissur.

6. The committal of the case shall be notified to the Public Prosecutor.
