This case having been heard finally on the 07<sup>th</sup> day of April 2026 the court on the same day delivered the following:-

**COMMITTAL ORDER**

1. This case is taken on file upon a final report filed by the Sub Inspector of police, Pudukkad Police Station in Crime No. 1713/2025 of that police station against the accused alleging offences punishable under sections 281,125(a),125(b) of BNS.

2. The prosecution allegation against the accused is as follows:-

On 2-12-2025, accused drove motor cycle bearing registration No. KL-45-L-3065 along with CW3 as pillion rider through Thalore – Thaikkattusery road from west to east direction in a rash and negligent

manner so as to endanger human life and when the vehicle reached near Mathrubhoomi printing press, it hit on the scooter bearing registration No. KL-45-K-8365, which was driven by CW1 along with CW2 as pillion rider. Thereby CW1, CW2 and CW3 fell on the road and they sustained injuries / fractures on various parts of their body. Thus the accused is thereby alleged to have committed the aforementioned offences.

3. Accused appeared before the Court and was enlarged on bail. Copies of relevant prosecution records were furnished to the accused. After the preliminary hearing and on perusing the records, it is found that one of the injured (CW3) is minor. As per S. 86 substituted by the Amendment Act of 2021 to Juvenile Justice (Care and Protection of Children) Act, 2015, offence against children is to be tried by Honorable Children's Court. Hence the case is refiled as CP 33/2026 and is hereby committed to the Hon'ble Children's Court, Thrissur u/s. 362 of BNSS.

4. The accused who is on bail, is directed to appear before the Hon'ble Children's Court, Thrissur as and when directed.

5. Submit the entire records of the case and documents to the Hon'ble Children's Court, Thrissur.

6. The committal of the case shall be notified to the Public Prosecutor.
